- **Cultural Scholarships:** Given to students excelling in cultural activities.
- **Defence dependant scholarship:** Provided to all persons belonging to family of defense personnel.
- **Special Scholarships:** Allocated for students who hold the rank in the following national level entrance exam:
JEE (MAINS)
UPSEE


