

Report on Anti-Ragging Activity Organized by Invertis University

Date: August 22, 2022

Organized By: Professor J N Srivastava, Chief Proctor

1. Introduction: Invertis University takes immense pride in fostering a safe and welcoming environment for all its students. As part of its commitment to providing a ragging-free campus, Professor K K Dubey, along with the support of the university administration, organized an Anti-Ragging Activity on August 22, 2022. 

- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.


