# COMPENSATION AND BENEFITS

#### BASIC SALARY

You will be eligible for a basic salary of Rs 14,784/- per month.

# BOUQUET OF BENEFITS (BoB)

### 2. Leave Travel Allowance

You will be eligible for annual Leave Travel Allowance which is equivalent to one month's basic salary or a pro-rata amount in case you join during the financial year.
