BASIC SALARY

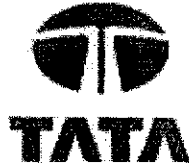

1. House Rent Allowance (HRA)

Your HRA will be Rs .5,914/- per month. While restructuring your BoB amount tovarious components, it is mandatory that at least 5% of monthly basic pay be allocated towards HRA.

2. Leave Travel Allowance

You will be eligible for annual Leave Travel Allowance which is equivalent to one month's basic salary or a pro-rata amount in case you join during the financial year. This will be disbursed on a monthly basis along with the monthly salary. To avail income tax benefits, you need to apply for a minimum of three days of leave and submit supporting travel documents.

3. Food Card

You will be eligible for a Food Card. It can be used to purchase food items at all domestic VISA enabled restaurants and fast food restaurants including TCS cafeterias. As per the Pre- Defined structure you will be eligible for a Food Card with an amount of Rs.500/- being credited to this card per month.
