- 4) During the training period you will not be entitled for any leave. Any leave availed during this period will be dealt with strictly and your stipend amount will be adjusted accordingly.

- 12) In case you commit any breach during the training period or you are found not satisfactory or not attending to the training regularly or found guilty of any misconduct or a nuisance to any of the employees of the COFORGE LIMITED or found guilty of any misbehavior COFORGE LIMITED will be entitled to discontinue your training and remove you with immediate effect.
- 13) In case you commit any breach of training/discontinuation/termination/refusal of acceptance of employment after successful completion of the training term, Rs.75,000/- (Seventy Five Thousand Only) will be recovered towards training/loss of opportunity and all other expenses incurred on hiring you as a trainee resource.
- 14) On successful completion of your training period, i.e. after you come on rolls of COFORGE LIMITED LIMITED, you have to sign a service agreement with the company for a period of 24 months.


