1. House Rent Allowance (HRA)

Your HRA will be Rs .5,914/- per month. While restructuring your BoB amount tovarious components, it is mandatory that at least 5% of monthly basic pay be allocated towards HRA.

2. Leave Travel Allowance

You will be eligible for annual Leave Travel Allowance which is equivalent to one month's basic salary or a pro-rata amount in case you join during the financial year. This will be disbursed on a monthly basis along with the monthly salary. To avail income tax benefits, you need to apply for a minimum of three days of leave and submit supporting traveldocuments.

3. Food Card
