- I know that shift timings and work hours vary based on the business I am assigned to and that I may be required to work in the night. Yes No

- I know that if the shift starts or ends between 7:00 a.m. and 8:00 p.m., transport will be provided only from the pickup points and to drop points.
- I am aware that ATM machines and Bank representatives will be available in office premises to help me with my banking requirements (on specified days only).

G) Leaves

- I know that a Genpact India full time employee is entitled to 25 days of leaves given on a prorata basis, based on date of joining.
- Over and above 25 leaves, employees get festive offs which are different for different processes / locations.
- I know that earned leave can be carried forward and accumulated to a maximum of 30 days. Any leave beyond 30 days will lapse if not availed. Encashment of earned leave will be allowed only at the time of separation from the company and will be governed by the existing policies.
- All leave requested are subject to approval of the manager.
- All exceptions on leaves as agreed with the operations manager will be honored as documented here.
- I know my weekly offs can be staggered or fixed based on process requirements.
