The OBC Standing Committee ensures the effective implementation of the policies and programs of the Government of India, UGC, and state governments with regard to backward castes. It also suggests measures for achieving the objectives laid down by the various government agencies. The committee meets at least two times in a year, and the decisions arrived at are mandatory to be implemented. The committee functions under the chairmanship of the vice chancellor.

Functions of the OBC Cell

- To circulate Government of India's and the commission's decisions regarding course-wise admissions to candidates belonging to the OBC
- To circulate the Government of India orders and commissions' decisions and to obtain information in respect of the appointment and training of these communities in teaching and non-teaching posts in the universities in suitable forms by a stipulated date and take follow-up action whenever required.
- To obtain reports and information regarding the Government of India orders on the various aspects of education, training, and employment of OBC for evolving new policies or modifying existing policy by the commission.
- To analyze the information collected above and prepare reports and direct it for onward transmission to the Ministry of Human Resource Development/University Grants Commission and such other authorities as may be required.
- To deal with representations received from OBC candidates regarding their admission, recruitment, promotion, and other similar matters in the university.
- To function as a Grievances Redressal Cell for the grievances of OBC students and employees of the university and render them necessary help in solving their academic as well as administrative problems.
- Any other work assigned from time to time to promote higher education among these communities suffering economic, social, and educational deprivations.
