**Key User Training:**

**Functional Training:**

The key user training will be conducted during the business process workshop by the CorporateServe team to the core team members of INVERTIS.

The objective of this training is to make the key users/core team of INVERTIS conversant on the modules and functionality of Microsoft Dynamics™ NAV and how it maps to the business processes of INVERTIS.

The key user training will help the INVERTIS team to work along with the CorporateServe team during the implementation and during post implementation they will be able to handhold the end users and attend to user queries and do trouble shooting.

**End User Training:**

The end user training will be given over a period of 7 days and this will be done during the implementation after the configuration and testing is over.

The number of batches to be trained and the locations where the training needs to be held will be arrived at.

The objective of the train the trainer method is twofold. Firstly, the acceptability of the new system by the end users is more if their own people advocate and train them in the new system and the processes. Secondly, once the CorporateServe team moves out, the INVERTIS team can become fully conversant in the handholding and the trouble shooting part for taking care of the new system, which has gone live.


